## Special Needs Planning

If you have a loved one with special needs, you are no doubt aware of the importance of government assistance programs such as Medicaid, Social Security Disability Insurance (SSDI), and Supplemental Security Income (SSI) in helping your loved one receive and pay for the care he or she needs. You also are well aware that this assistance is often not enough to allow you to provide them with the best possible care. Special Needs Trusts are critical planning tools that allow for the provision of services not covered by government programs while at the same time preserving eligibility for these programs.



## What Makes Special Needs Trusts Special

Special Needs Trusts can be created by individuals under age 65 using their own assets, such as proceeds acquired through a settlement or judgment. They also can be created with funds from a disabled person's family and other loved ones. Special needs trusts offer a wide range of benefits, such as:

- The preservation of eligibility for government assistance programs
- The provision of funds to pay for goods and services not covered by government benefits, such as advanced medical and dental care, specially-equipped vans, training and education, travel, recreation and entertainment, electronic equipment, a car, ride share membership, a bus/rail pass, a home, help with starting a business, and more
- The protection of family assets and funds from a settlement
- The peace of mind that comes from having a fund to pay for a loved one's future care
